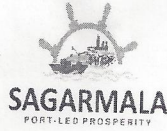

Sub: Monthly report on Swachh Bharat Abhiyan

Sir,

In continuation of earlier correspondence on the subject matter, the action taken report for the month of November, 2016, as a part of Swachh Bharat Abhiyan, pertaining to this port, is furnished hereunder:-

During the month of November, 2016, as usual regular weekly cleanliness and Awareness Drive at the surrounding areas of the port was continued by deploying staff of various departments at the different designated areas, in a batch-wise manner. In addition to above, all the activities, as chalked out under 22 points programme on Swachh Bharat Abhiyan, were also undertaken regularly in co-ordination with the staff of different departments of this port.

Besides, in pursuance to guidelines issued by the Ministry vide letter no. CD-11053/24/2016-Coord. dtd. 18/7/2016, Swachhta Pakhwada was conducted at this port from 11th to 30th November, 2016 under the control of the undersigned by the staff of General Administration Department. During this Swachhta Pakhwada, various staff of the General Administration Department of this Port were deployed in a batch wise manner to undertake different cleanliness activities as suggested by the Ministry of Drinking Water and Sanitation (DWS) viz. Basic Housekeeping, Contribute the Surrounding Areas, etc. The employees were deputed for a duration of one hour in the morning session to conduct cleanliness outside the office premises and for a duration of one hour during second session in the office premises. It may further be noted that as a part of Swachh Bharat Abhiyan, action is being initiated to put into use the Roster so as to monitor the different activities undertaken at this Port in connection with the Swachh Bharat Abhiyan under the respective control of each Heads of Departments of this Port.

It may kindly be noted that for the period from April, 2016 to November, 2016, altogether 17 events have been conducted in connection with the Swachh Bharat Abhiyan at this Port.
