**TRADE NOTICE - RFID BASED ACCESS CONTROL: GO-LIVE**

After the successful trial implementation of RFID based access control system, with the active support of all member of MPT Trade fraternity, we are now into the full fledged implementation of this system. Henceforth, the access to the operational area of the Port would be exclusively through the web-based RFID base access system only. The passes shall not be issued manually henceforth and only in the event of extreme exigencies when there is a system or power failure, issue of manual passes shall be resorted to.

All Port Users are requested to advise that their staff, officials, service providers as well as the Principals to invariably make use of the Gate Access module through our official website for obtaining the access control passes.

The payment towards RFID cards shall be made either online or through Demand Draft/Banker's Cheque drawn in favour of FA&CAO, MPT. Small amount upto Rs.1,000/- shall ONLY be collected in cash at the Cash Section, Finance Department, MPT.

With the implementation of the RFID based access system, there will be absolute pass-through/drive through for the vehicle as well as personnel, once the RFID Card Reader registers the particulars of entry/exit. With this, the need to flash/produce the identity card to the CISF personnel at the gate is dispensed with. The CISF personnel shall not stop the vehicle/personnel for any kind of verification except for security exigencies.

The Stevedores and Transporters are advised to obtain/register for access passes well in advance before sending their vehicles/personnel to the Gate No.9 so as not to cause any congestion at the Gate. Any vehicle which seeks gate access after arriving at Gate No.9 shall not be allowed entry (except in exigencies) and is liable to be barred from further entry. This is primarily to ensure that unscheduled vehicles do not hinder free flow of traffic.

The vehicles engaged in inter-carting inside the port area shall be allowed entry/exit for fuelling purposes and shall not be detained at the gate by the CISF.
