TECHNICAL SPECIFICATION

1.0. GENERAL

Mormugao Port Trust invites a quotation for the work of “Supply of 2 nos. 8GB RAM”.

2.0. GENERAL TERMS AND CONDITIONS

2.1. Validity:

The validity period for the offer shall be 45 days from the date of opening of the quotation.

2.2. Price:

The evaluation shall be on the basic price. The rates offered shall be exclusive of GST. If any new tax imposed by the State/Central Govt., same shall be reimbursed by producing documentary proof.

2.3. Completion Period:

The entire work shall be completed within 8 days from issue of LOA/PO.

2.4. Guarantee Period:

The Contractor shall guarantee the work for a period of **1 year** from the date of supply. Any defect observed during the guarantee period, the same shall be rectified by the Contractor, free of cost.

2.5. Payment Terms:

- i. 100 % payment shall be made within 15 days after satisfactory completion of work on producing invoice complete in all respects.
- ii. The contractor shall furnish their bank account details for the payment through ECS by the Trust. A copy of the PAN card, Service Tax Registration no, MICR number Name of the Branch along with Bill for arranging payment made through E.C.S. by the Trust.

2.6. Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 0.5% of contract price per week or part thereof subject to a maximum of 5% and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor.

2.7. Other terms and conditions

- i) Necessary Harbour Entry Permits shall be obtained by the Contractor at their own cost with the approval of Port Officials.
