## **Annexure – I**

### **Scope of work:**

#### **The Scope of work for replacement of snapped wire ropes of High Mast No. 48.**

1. Cleaning of site surrounding the High Mast for making easy access for the Crane for the lowering of High Mast structure. Disconnection of main supply, removal of all connections and lantern carriage.
2. Removal of lantern carriage, loosening the foundation bolts, and lowering of High Mast structure and removal of snapped wire ropes of High Mast.
3. Replacement of steel wire rope after removal of wire ropes from the structure of High Mast No.47 which was removed and kept aside near V-2 Shed. (Wire ropes will be supplied by Port).
4. Leveling of lantern carriage and clamping of wire rope.
5. Cleaning, oiling and greasing of wire ropes, pulley, gear mechanism, sprocket chain, motor etc.
6. Hoisting of High Mast structure after replacement of both the wire ropes.
7. Re-connection of cable after clamping, hoisting of lantern carriage, testing and re-commissioning. (Crane will be provided by Port free of cost subject to availability).
8. The old materials shall be returned to Power House, Baina.

## **Annexure-II**

### **Terms & Conditions**

1. Security Deposit: 10 % of the contract value will be deducted from the bill.

2. Safety:

It will be entirely the contractor's responsibility to take required steps to adequately safeguard the personnel carrying out the work and to ensure that the work is carried out in such a manner that maximum safety to the personnel is assured. Further any insurance etc of the personnel as per regulations in force has to be taken care by the contractor.

3. Completion period:

Entire work shall be completed within 4 days from the date of receipt of Purchase order by the contractor.

4. Payment Terms:

100% payment shall be released within 30 working days after completion of entire work. However the bill should be undisputed in all respects and submit the complete report/relevant documents along with the bill.

5. Liquidated Damages:

In the event of failure by the contractor to complete the execution of the work within the time stipulated in the contract or by the expiry of any period of extension granted by the Board's terms thereof, the contractor shall pay the Board as Liquidated Damages for delay to complete the work, a sum of 0.5% of contract price per week or part thereof subject to a maximum of 10% and the Board shall have the power to deduct this amount from the payment of the amounts due to the contractor or from his deposit.

6. Guarantee: - Entire work shall be guaranteed for a period of six months. However any defects/deficiencies during this period shall be carried out by the contractor at free of cost.
